

TERMS AND CONDITIONS

These terms and conditions have been drawn up based on Article 8, paragraph 1, point 1 of the Act of July 18, 2002, on providing services by electronic means (consolidated text: Journal of Laws 2020, item 344 with later amendments).

§ 1 Definitions

Organizer NABI LLC, 7901 4th ST, Suite 15415, St. Petersburg, FL 33702. Participant - an individual participating in the Webinar organized by the Organizer. Webinar/Event - a live online training organized by the Organizer. GDPR - General Data Protection Regulation of April 27, 2016 (Official Journal of the EU L of 2016, No. 119/1).

§ 2 Subject

The title of the Webinar is: "The latest requirements of biocompatibility for medical devices".

§ 3 Technical conditions

1. Participation in the Webinar requires a computer or another electronic device with Internet access, an active email account, and a proper software, including an appropriate web browser (Google Chrome, Mozilla, Firefox, Safari, Edge, Opera, and Yandex).
2. The Webinar will be conducted via the ClickMeeting program, which the Participant can use via a web browser link.
3. To use the service on selected mobile devices, downloading the appropriate application from the iTunes or Google Play internet store is required.

§ 4 Registration for the Webinar

1. To register for the Webinar, the Participant must provide its first and last name, email address, and company name in the registration form available on the website <https://nabi.bio/webinar/>.
2. The Participant is required to familiarize itself with the Terms and Conditions and confirm their acceptance by submitting a statement "I accept the Terms and Conditions".
3. After the Participant sends the registration's application, the Organizer may confirm the participation acceptance via email. The Organizer reserves the right to refuse any and all registration's requests without stating any cause. In the case of the lack of Organizer's confirmation, the Participant cannot participate in the Event.
4. The confirmation email will include a request to provide the invoicing details, for VAT invoice issuance if necessary - based on which payment will be made. If issuing a VAT invoice is not necessary, the Organizer will provide transfer details in the email. Do not apply for webinars free of charge.
5. A person registering on behalf of the Participant declares that it has power of attorney to act in his name and on his behalf, in particular, to enter into an agreement with the Organizer.
6. After expressing the wish to participate, the Participant will receive a registration confirmation for the Webinar via email, on conditions stipulated herein.

§ 5 Payment

1. The Webinar is free of charge.

§ 6 Course of the Webinar

1. The Webinar will take place live, via the Internet, on the 08.05.2024 (May 8th).

2. The Webinar will be conducted in English.
3. The duration of the Webinar is 1,5h and starts at 1pm ET
4. The Webinar program is available on the Organizer's website.
5. The Participant will receive a meeting link from the Organizer via email, before the Webinar starts.
6. Recording, reproducing, disseminating and sharing of the Webinar's content is strictly prohibited.
7. Sharing access data for participating in the Webinar with third parties is prohibited.
8. The Organizer reserves the right to change the program or the technical conditions of its organization, which will not constitute a violation of the Terms and Conditions.
9. The Organizer is not responsible for situations where the Participant cannot participate in the Webinar due to circumstances on the Participant's side.

§ 7 Complaints

1. A complaint related to the service may be submitted by the Participant electronically via the contact form on the website: <https://nabi.bio/contact/>.
2. When submitting a complaint, the Participant provides its data and a detailed description of the reason for the complaint.
3. The Organizer has 4 weeks to consider the complaint from the date of receipt.
4. The Organizer will respond to the complaint via email to the address specified in the complaint submission.

§ 8 Withdrawal from the Agreement

1. The right to withdraw from the Agreement is granted within a term of 14 days counted from the day of Agreement's conclusion, without giving any reason. The withdrawal period is counted from the day on which the Participant has submitted its application.
2. The Participant withdraws from the agreement by submitting a declaration of withdrawal to the Organizer via email.
3. The refund of the price paid by the Participant will be made immediately, no later than within 14 days counted from the day of receiving the declaration of withdrawal from the Agreement.
4. The right to withdraw from the Agreement does not apply to contracts where the Organizer has fully provided the service with the Participant's explicit consent, who has been informed that after the service is completed by the Organizer, they will lose the right to withdraw from the agreement.
